#### I. Introduction

The University of Hawai'i (UH), under the leadership of President David Lassner, is actively engaged in promoting efforts that support safe, inclusive and nondiscriminatory campus environments systemwide. As part of these institutional efforts, UH is committed to ensuring that members of our campus community can utilize many resources and options available, as part of UH's commitment to addressing all reports received through its offices of notice or its confidential resources at each campus, as appropriate.

UH, through this report created pursuant to Act 242, Session Laws of Hawai'i 2022, addresses the Legislature's request for information pertaining to its case management data at each UH campus.

#### II. Data for Academic Year (AY) 2022-2023

The tables for each campus below summarize 1) the numbers of complaint data, which includes combined total received by Title IX, Confidential Resources, including advocates and mental health counselors, at each campus; and 2) the percentages of either online or in-person training completion data on the University's Title IX policies and procedures, and on any other policies and procedures adopted by the University in accordance with HRS Ch. 368. Also, the types of prohibited misconducts reported are specified for each campus.

In providing the complaint data below, please note that a single report/incident may be double counted as the numbers for each campus include data from both confidential resources and Title IX Coordinators. For example, if the same complainant or victim seeks resources from multiple offices, or if working with a confidential resource empowers a complainant to move forward with reporting information to a Title IX Coordinator. Additionally, cases involving multi-campus may also contribute to double-counting (e.g., if a complainant files a complaint and seeks services from multiple offices because they are enrolled at multiple campuses, or if a complainant and a respondent in a case are affiliated with different UH campuses.

In Identifying the types of prohibited behavior for the purposes of reporting on the types of complaints, please note that some cases may include more than one alleged prohibited behavior.

In providing percentages for training course completion, training data was organized based on the type and format of the course provided. Online training data has been rounded to the nearest whole percent. Also, for the online training for students, different versions of the training modules are customized for graduate, undergraduate, and community college students.
