Not at this time as the product (as well as Microsoft and Google derivatives) continue to evolve. We would caution anyone using these AI products that they also collect and keep the context of requests, so anyone using them should be aware that it's the equivalent of typing on a public bulletin board. The products have material merit, but it is unclear as to how they will impact (or benefit) the University and its community.

Yes, together with range of other topics; recognize that the area is evolving quickly so only limited curriculum exists for AI connected to workforce development.

Financial models that rely on recurring replacement don't work (yet) for UH. We do have to do better with standardization and effective pricing as sometimes the standards cost a bit more. VoIP migration to Mitel in the works coming soon:)
What is the timelime of the replacement for Laulima?	The current work is to assess and evaluate the alternatives - that effort will be complete in the Spring. Based on the results, we will set our next steps.

You have to purchase Yubikey hard tokens for use with DUO from the UH Site License program: www.hawaii.edu/sitelic - it needs to be configured to work with our DUO.
How are the hard tokens available for those on the other islands?	We utilize USPS, and provide some instructions on getting the hard token fully provisioned to work with your account.
GOOGLE UPDATE	
Is there a limit of how many Google shared drives done by a user?	Not at this time, though we will monitor and may put limits in place if the number of requested shared drives for individual accounts becomes an issue.
Is there a way to tell how much space is being used per shared drive and in total? If there are multiple content managers, who's quote is being taxed?	Refer to https://www.hawaii.edu/askus/1882 for instructions to see the quota usage for an individual account, as well as for shared drives.

Will these shared drives or total usage exclude email messages and attachments?	Email messages and attachments contained in an individual's account would count towards the account's quota (see https://www.hawaii.edu/askus/1882 for more details).
'Ohana folks can do regular gmail and get 15GB of gDrive storage :)	We intentionally set the 'Ohana account quota under the consumer gmail.com account quota, as 'Ohana accounts are intended to be used specifically for ongoing communication with faculty and staff of UH, and is not intended to be used as a personal Gmail/Drive account after separation from UH. Personal communication and file storage should be done under a consumer account, whether gmail.com or another service.
Will the quota exceptions apply to departmental accounts?	Yes.
Can the quota exception request be for the Google Shared drives as well?	Yes.
Will there be training to use these options?	We don't have any training sessions on the calendar at this time, but will look to put together some sessions.
Hi Mitch - we host a lot of shared drives for our larger research projects, primarily for documents, reports and presentations. Does the quota pertain to the google drive "owner" or to members of the shared drive.	Shared drive quotas apply to all files within the shared drive. This quota would not apply to the individual account quotas for any of the collaborators of the shared drive. Files within an individual account's "My Drive" would count towards that account's quota.
How do you find files taking up large amounts of storage in google drive?	https://hawaii.edu/askus/1882
messages stored in Google Groups archive does it count against one's quota?	No, messages stored in Google Groups archives do not count towards any of the group member's individual quotas.
Will quota exceptions apply to research data? Many investigators store large amounts of research data in google drive.	Yes.
Back to Google Groups - what is the quota limit for a Google Group?	Right now, we don't know if there are any default quota for Google Groups, nor if Google provides a way to apply a quota like there are for individual accounts or shared drives. Update: Google Support confirmed that Google Groups don't have a storage quota, and the messages and attachments available through the Google Groups UI for a group does not count towards the domain's total pooled storage limit. Ask Us 1882 has been updated to reflect this in the FAQs section.
Mitch is there a way to transfer ownership of a Google Drive folder if that owner had left UH?	Yes. You can contact the ITS Help Desk for assistance with this.
