Aloha Chair Tochiki, Vice-Chair Haning, and Members of the Committee:

Mahalo for the opportunity to provide testimony.

As the student governance group of the University of Hawai'i, the UH Student Caucus (UHSC) is formally authorized to serve as a system-wide association of all University of Hawai'i campus student governments, representing approximately 50,000 students across the 10 campuses of the UH System.

# The UH Student Caucus offers comments for serious consideration relating to all three UH Hilo student fee proposals.

<u>Student feedback indicates a majority opposition to the proposed increases.</u> While the sample size is not ideal for a comprehensive attitude assessment of the UH Hilo campus, what has been provided indicates a large degree of hesitation in regards to the fee increases. Some students also indicate that there is a lack of understanding as to why the fees must be increased and to such a large degree.

Student feedback indicates that a significant percentage of students are concerned by the magnitude of the fee increase. With the size of the fee increases surpassing 100% many indicated alarm. If the fee increase to such a degree is necessary and cannot be reduced to a more acceptable number then it is suggested that such an increase take place over a longer period of time, to be determined by further student feedback.

<u>Student feedback indicates that the proposed fee increase, while addressing those with financial insecurities in its implementation, still fear for their financial stability.</u> While the proposed increase also includes stipulations to address those on financial assistance programs many students still feel that their financial security is at risk.

Aloha mai kakou a pau,

We are writing about the student fees at UH Hilo - athletic fee, life center, engagement.

We have one child who already graduated from UH Hilo, one is in her junior year at UH Hilo and our youngest son is in his senior year of high school. Our youngest wants to go to UH Hilo too but now the fees are making us question that.

None of our children or our ohana attend athletic events because we are busy with full-time jobs, volunteering with our homestead association and proudly living our lifestyle. We are active in the Hilo community but not in athletics. It doesn't make sense for this fee to be charged to all students. Like the theater, only the people who CHOOSE to attend the events need to pay to enter. Why can't athletics do that? This fee seems to benefit mostly the athletes. It's not fair for the rest of the students to cover the expenses for a small group of students. The proposal says there are unique challenges for UH Hilo Athletics. The university has a lot of leaders who get paid a lot of money. They should plan to deal with the unique challenges. They shouldn't pass those challenges on to the students and us parents.

For the same reasons that we don't go to athletics events, our children also don't go to the student life center. They are still active working in our lo'i and the loko i'a we help caretake. A \$100 increase is more than double what it is now. An increase of that amount should happen over time. This feels like students are being asked to pay for bills that the university neglected to pay attention to over time. They should try to find other ways to pay for this. Why put this cost on to students who might not use the center? The proposal says the long overdue fee adjustment of \$100. It's not the student's fault that the university failed to plan better.

But most confusing of all is the student engagement fee. I paid \$10 for my first son and my daughter's UH Hilo IDs. The other things mentioned as a benefit for this fee is fluff. It's the kind of thing that the university has been doing for years and did a great job of doing under the prior leaders. Why is there a need for a fee now? I asked a cousin who works for a different college and she said they get a budget from their administration out of tuition payments. Why can't that be done instead of a separate fee that is REALLY high. I don't see how my child will get \$200 value out of this fee.

Regents please do not allow UH Hilo to continue adding on more cost to the price of college. We fought hard to keep our keiki home. If costs continue to go up at home, the cost of sending our keiki away looks more attractive. That's not what we want for our ohana or our lahui. Please do not pass these proposals. UH Hilo should find other ways to pay for this.
