CLEAR Interim Director's Report - Dr. Leslie Lopez

- Rutledge Endowment The market value of the endowment as of November 19, 2024, is \$1,125,500.46
- Labor Studies Certificate

Dr. Lopez shared with the council that Dr. Keshawarz is currently working on an assessment report for the Certificate. Course offerings through the CS3 Program allow students to take LBST courses at the UH System Community Colleges without fees and at the CC tuition rate. CLEAR is working on communicating with the CC advisors to raise awareness on their campuses. Will present to move from provisional status to permanent after the assessment is complete.

A brief discussion occurred about the expansion of the Labor Studies program to possibly offer a bachelors degree

New Staff Orientations and Projects

Dr. Lopez reported that Dr. Keshawarz visited the Unfair Labor Practice Strike on Maui to interview

nurses on strike dealing with the privatization of public resources. Dr. Keshawarz is also co-teaching LBST 300. He is also creating a curriculum map for UH's transition of its course management system from Laulima to Lamaku.

• Filling Staff Vacancies

Dr. Lopez reported that the CLEAR Digital Archivist position has been approved but not posted yet. She is communicating with the VC for the reason for the delay. There is a large backlog of informational requests for the archives.

There are (3) public presentations for the finalists of the CLEAR Director position. One presentation was held last week and two more are scheduled for this week.

 Ah Quon McElrath Project (<u>https://www.laborhistoryhawaii.org</u>) Joy Chong-Stannard reported that Ah Quon McElrath documentary was broadcasted on 10/17/24 on PBS. The AQ Premier, a kick-off event for the documentary was scheduled on 10/1/24. It received great feedback and is accessible on PBS' YouTube for a year. PBS maintains the site and has been supportive of the project. ILWU recognized for their contribution to access resources from their archive collection to complete the documentary.
