# Labor Education Advisory Council Resolution Requesting Emeritus Status for Dr. William Puette

Whereas Dr. William J. Puette retired as CLEAR Director and Faculty Specialist on December 31, 2023, after 41 years of service; and

Whereas, as faculty at the Center for Labor Education & Research, Dr. Puette has since 1982 has taught non-credit workshops on Labor History, Collective Bargaining, and Labor Law to thousands of workers and their organizations throughout the State, and pioneered the Continuing Education Unit (CEU) program at UHWO; and

Whereas, as a nationally respected scholar, Dr. Puette's published works include most notably his history of the Hilo Massacre, and his detailed analysis of the Media portrayals of organized labor, for which he received the Lowell-Mellett Award for Media Criticism from Penn State University in 1993; and

Whereas Dr. Puette upon unanimous election. served as Chair of the UHWO Faculty Senate from 2004 to 2006; and

Whereas, As director of the Center for Labor Education & Research, since 1996, Dr. Puette created the Center's award-winning Archive of Hawai'i's Labor History and the acquisition, renovation, and installation of the Isami Enomoto Labor Murals at no cost to the University of Hawai'i; and

Whereas Dr. Puette received the Hung Wo and Elizabeth Lau Ching Faculty Service to the Community Award from the University of Hawai'i in 2005; and

Whereas Dr. Puette received the 1994 George Meany Award for Outstanding Service to Youth, awarded by the Hawai'i State AFL-CIO and the Aloha Council of the Boy Scouts of America for teaching hundreds of free American Labor Merit Badge clinics to Boy Scouts in Hawai'i; and

Whereas, At its 2023 convention, the Hawai'i State AFL-CIO unanimously adopted a resolution to formally recognize Dr. William Puette for "his enduring contributions to labor education, arbitration, and leadership in Hawai'i" as a lasting tribute to his remarkable impact on the labor movement in Hawai'i; and

Whereas Dr. Puette meets and exceeds the eligibility requirements for an award of Emeritus Status described in UH Executive Policy 5.207; now, therefore, be it

Resolved, That the Labor Education Advisory Council request UHWO Chancellor Maenette Benham and UH President David Lassner to formally honor and grant or recommend that the UH Board of Regents grant Dr. William Puette Emeritus Status in recognition of his decades of distinguished service to the University of Hawai'i as faculty of the Center for Labor Education & Research and as its director of the Center both at the Mānoa and West O'ahu campuses.
